## INTRODUCTION + PROGRAM OVERVIEW

### PROGRAM OVERVIEW

The REConstruct program aims to deliver community organisations such as sporting clubs access to premium solar panels and inverters, fully installed, at no cost.

Approximately 50 systems, each of about 6.5kw\*, are available, inclusive of racking and a premium inverter, all fully installed by a local, trained solar expert. The application process will be 'low-touch' and seek to avoid unnecessary bureaucracy.

The program aims to allocate all systems by end-2020, with installation to occur as soon as practicably possible. (where new buildings are being constructed, timelines will likely slip into 2021).

\*Note: actual system size will vary and be determined via application process up to a maximum of 10kw systems.

### ELIGIBILITY

To be eligible to apply for a free rooftop solar system under the REConstruct program, you are required to be a community-based organisation which has infrastructure that is located in a bushfire-affected region and has been adversely affected by the bushfires.

### KEY DEADLINES AND TIMINGS

Applications for the REConstruct program will be accepted until 31 December 2020. Within six weeks of application receipt, REC delegates and local solar installers will review applications. If successful, formal project approval will be granted in the fortnight following this process. The timelines for application review and approval are a guide only and REC will not be bound to these timelines.
